6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. If possible contain the spill. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations. As a water based product, if spilt on electrical equipment the product will cause short-circuits.

7. HANDLING AND STORAGE

Precautions for Safe Handling

Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area, out of direct sunlight. Store in suitable, labelled containers. Keep containers tightly closed. Store away from incompatible materials. Ensure that storage conditions comply with applicable local and national regulations. Protect from freezing.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Occupational exposure limit values

No exposure standards have been established for this material. However, the available exposure limits for ingredients are listed below:

Bitumen fumes

TWA: 5 mg/m³

Hydrochloric acid

TWA: 5ppm, 7.5 mg/m³ (Peak limitation)

TWA (Time Weighted Average): The average airborne concentration of a particular substance when calculated over a normal eight-hour working day, for a five-day week.

Peak Limitation: A ceiling concentration which should not be exceeded over a measurement period which should be as short as possible but not exceeding 15 minutes.

Biological Limit Values

No biological limits allocated.

Appropriate Engineering Controls

Provide sufficient ventilation to keep airborne levels below the exposure limits or as low as possible. Where vapours or mists are generated, particularly in enclosed areas, and natural ventilation is inadequate, a local exhaust ventilation system is required. Refer to relevant regulations for further information concerning ventilation requirements.

Respiratory Protection

If engineering controls are not effective in controlling airborne exposure then an approved respirator with a replaceable vapour/mist filter should be used. Refer to relevant regulations for further information concerning respiratory protective requirements. Reference should be made to Australian Standards AS/NZS 1715, Selection, Use and Maintenance of Respiratory Protective Devices; and AS/NZS 1716, Respiratory Protective Devices, in order to make any necessary changes for individual circumstances.

Eye Protection
