Community agreement - Proposed additional out of hours work at Jesmond

Dear Resident,

As discussed with you, the project team would like to undertake evening and night work outside our standard construction hours, through the community agreement provisions in the project's Environmental Protection Licence (EPL2176). Currently under the licence the project team can work a maximum of three nights per week, and we are seeking community feedback and agreement to work up to five nights a week from **July 2023**. This would reduce the overall duration of nightwork carried out on the project and lessen the potential extended impact on the local community.

This additional out of hours work is expected to have evening and night noise impacts at your property until **December 2025**. The construction will be on and around the intersection of Newcastle Road and the Newcastle Inner City Bypass at Jesmond (northern interchange).

The proposed work

Most of the work will be carried out during standard daytime construction hours. Construction of the northern interchange is progressing and includes earthworks, piling, installing bridge structures, road realignment, fencing, utility work, and road surfacing.

We are seeking community feedback to work up to **five nights** in a row between **6pm** and **7am** on **Sunday to Thursday**, weather permitting.

Why is work done outside of standard construction hours?

We work out of hours to:

- improve safety by minimising the interactions between road users, pedestrians and workers
- minimise delays and journey times for motorists and businesses
- shorten the length of construction for the overall project

Some of the work we are doing in this area is completed outside of standard construction hours where it meets the conditions of our Environment Protection Licence (EPL2176).

Where out of hours work does not meet the conditions permitted by our licence, we are required to seek your agreement and feedback to carry out the additional work.
